## Lawyers for Learning: Dream Come True

What do you dream about? Retirement? Winning the lottery? Or maybe it's much more troubling than that. Maybe you dream about leaving a job or a relationship. For thousands of young people right here in Oklahoma City, their dreams are of something that we as lawyers often take for granted. They dream of finishing a chapter book; they dream of graduating from high school. And if their dreams are really big, they dream of going to college. In short, they dream of breaking the cycle of poverty. Oklahoma City public schools currently serve about 43,000 children, and 90 percent of them live at or near poverty level. Some of them don't dare to dream at all.

I never had to worry about learning how to read - I already knew how to read before it was expected of me. I finished high school before I realized that some people couldn't or didn't. I finished college while watching some people lose interest and quit. And then I finished law school, although there were several that dropped out. Getting more education was never a challenge for me - it was just something I did, without thinking. And then once I had all of that education, I dreamed that maybe one day I could help young people who don't have that instinct or those means.

As I entered the 7th grade, Judge Luther Bohanan issued a long-anticipated order, following the U.S. Supreme Court's dramatic ruling in Brown v. Board of Education of Topeka. To me, it meant that I only had to spend two years in what they were now calling "middle school." It also meant that I'd spend four years at John Marshall High School with half of my childhood friends being bussed over to Northeast. I was officially a product of desegregation.


After the "Finger Plan" was implemented in 1972, Oklahoma City public schools were never the same. The district experienced a drastic decline in enrollment over the following decade. By 1980, the district
